Rules & Regulations.

1. Name. The Society shall be known by the name & Title of "The Numismatic Society of Victoria" (hereinafter called the Society "Soc^y")

2. Objects. To further the interests of the Study of Numismatology amongst the Collectors and public of Victoria, and to induce the public to preserve any Numismatic Specimens, ^{Medals} or literature relating to same, of interest to Australians or others:
And for the exhibition of any Rare or uncommon Specimens or anything the members think will be of interest to the Soc^y at the usual meeting. *

3. Position of Members. Initial Members shall bear the title of Fellows of the Soc^y (F.N.S.V) - Future Fellows shall be elected by vote - but - to be eligible must have done something to further the interests of Numismatology, either in conjunction with the Society or publicly - Ordinary Members

Election of Members. - Prospective Members must be proposed & seconded by Members of the Socy. - If four fifths vote "aye" the Member shall be declared elected.

5. The Society shall be managed by a

COMMITTEE. Managing Committee, consisting of a
President - Two Vice Presidents, Secretary,
Treasurer & a Committee of Two Members.

6. The Annual Subscription shall be
SUBSCRIPTM. Seven Shillings & 6

7. The Meetings shall be held every month
MEETINGS. or oftener, if the Managing Committee
think it advisable.

8. Any Members having specimens they wish
to sell ~~shall~~ ^{may} deposit them with the Sec^{ry}
SALES. before the meeting commences - the Secretary
will show them to the Members - and if a
sale takes place the sum of 5% of the
sale price shall be retained by the Society,
to be used towards the publication of reports

or general expenses.

FUNDS 9. The funds shall be used by the Managing Committee in payment of ordinary ~~and~~ working expenses - such as - rent of meeting place - office - stationery - postage - lighting etc - Any extraordinary payments or donations must be reported to a General Meeting for confirmation before being paid.

10 . Any member changing his or her address shall notify the Secretary as early as possible.

11 . Order of Business at Meetings.

12. Payment of Subscriptions. Notice of the falling due of Annual Subscription shall be given to each member by the Secretary - and if the subscription is not paid within three months membership shall cease.
